PROHIBITED DUTIES FOR ALL MINORS:

(See regulations for a complete listing of prohibited jobs.)

- Regular driving of motor vehicles. • Boilers or in engine rooms.
- Mining & explosives. • Earth moving machines.
- Elevator operation/repair. • Logging.
- Flaggging. • Power-driven machines.
- Excavating. • Nurses aid or assistant.
- Roofing. • Fire fighting.
- Work in freezers, meat coolers & in preparing meats for sale.
- Selling candy, flowers, etc., to motorists on public right of way.
- Work performed more than 10 feet above ground/floor level.
- Manufacturing of brick, tile & kindred products.
- Wrecking, demolition and shipbreaking operations.
- Slaughtering, meat packing or processing.
- Work in saunas or massage parlors.
- Jobs requiring personal protective equipment.
- Jobs with possible exposure to bodily fluids, radioactive & hazardous substances.

PROHIBITED DUTIES FOR MINORS UNDER AGE 16:

- House-to-house sales. • Processing operations.
- Manufacturing. • Amusement parks.
- Public messenger. • Loading/unloading trucks.
- Any power-driven machinery.
- Transportation, warehouse, storage & construction.
- In the following areas of retail, food or gasoline services:
Maintenance/repair.
Window washing.
Cooking & baking.

**Note: For 16- and 17-year-old workers only, 6 hour shifts and up to 28 hours per week are available through a special variance from the school district.

Minors have to be 14 years old to work at non-agricultural jobs. However, a minor under 14 may be employed with the written permission of a Superior Court judge. These minors are then permitted to work the same hours as listed for 14- and 15-year-olds.

Minors working after 8:00 p.m. in service occupations, such as restaurants and retail businesses, must be supervised by an adult.

**Agricultural Employment of Minors
WAC 296-131 (001-140)**

PROHIBITED DUTIES FOR ALL MINORS:

(See regulations for a complete listing of prohibited jobs.)

- Handling, mixing, loading or applying dangerous pesticides.
- Transporting, transferring or applying anhydrous ammonia.
- Handling/using blasting agents such as dynamite/blasting caps.
- Operating power saws, power-driven wood working & metal forming, punching or shearing machines.
- Work involving slaughtering & meat processing.
- Work involving wrecking, roofing, demolition & excavation.
- Harvesting crops prior to the expiration of the pre-harvest interval or within 14 days of chemical application if no pre-harvest interval exists.

PROHIBITED DUTIES FOR MINORS UNDER AGE 16:

(See regulations for a complete listing of prohibited jobs.)

- Operating or riding on a tractor.
- Operating or assisting to operate machines like corn pickers, hay balers, mowers & grain combines.
- Working in such hazardous jobs as manufacturing, meat packing or food processing.
- Working on a farm in a yard, pen or stall occupied by a bull, boar or stud horse maintained for breeding purposes.
- Working from a ladder or scaffold at a height over 20 feet.
- Driving a bus, truck or automobile when transporting passengers.
- Working inside a fruit or grain storage designed to retain an oxygen deficient/toxic atmosphere, or working in a manure pit.
- Working in transportation, warehouse & storage or construction.
- Working in or about engine or boiler rooms.
- Operating a trencher, earthmoving equipment, fork lift or potato combine.
